Less sessions could be selected in the designed schedule with 2 parallel tracks (3 on 2023). The shorter format of sessions were balanced to be considered besides dominant panel format. Other formats have been received such as pitch and Open Mic.

Highlights #3

Overall diversity of attendees and speakers was satisfactory, which has always been one of the goals of APrIGF.

Moreover, number of economies significantly increased and seemed we have followed up from last year statistic to improve and connected with the missing communities that have joined.

APrIGF Fellowship 2024

A total of 586 applications were received, with 211 from females and 371 from males, and 32 fellows were selected in the initial round, evenly split between 16 females and 16 males. Only 28 fellows could make it till the end.

Diversity and inclusion have been taken much into consideration during selection process. 28 international fellows came from 18 different economies/countries. There were 13 female fellows and 15 male fellows remaining in the selection. Meanwhile, TWNIC selected 8 local fellows.

TWNIC supported the accommodation for all international fellows and two local fellows. Taipei travel cost was lower than last year.

Prospect of APrIGF 2024

 APrIGF has strategically grow this year towards a regional hub - that co host with <u>7 side events</u> in same city at same week. This could be an <u>annual momentous</u> week of Internet Governance Asia Pacific.





Prospect of APrIGF 2024

- The Multistakeholder Steering Group (MSG) has formed a working group of previous leaders to focus on the sustainability of APrIGF model, with the objective to make it more attractive to local hosts, sponsors and partners.
- PR and media coverage have still been an issue for APrIGF. The MSG is looking into Stakeholder Engagement Committee (SEC) on promoting the event more proactively. > SEC may change to ad-hoc committee instead of standalone one





Future Plan for IGF 2025

- Continue annual momentum to collaborate with other side events as a week of Internet Governance
- More Strategic PR and communication efforts
- Increasing engagement in IG process int' level (e.g. IGF 2025, WSIS+20)
- Maintain Strong Government relations (local and regional)
