This notice provides the dates and details of the DotAsia Board Elections in accordance with the DotAsia Board Elections Procedures (BEP – <u>https://dot.asia/BGC-004/</u>).

NOTE: In this draft square bracketed parts [example] are meant to be for if the Proposed Amendments to the DotAsia Articles are adopted by Members and the Board Elections 2024 will proceed based on the new DotAsia Articles.
