The Nomination Committee will determine the eligibility of candidates, establish and enforce an Elections Code of Conduct, and nominate a person for appointment to the DotAsia Board directly every 3 years or if the seat is otherwise vacated. An appointment was made in the Board Elections 2024 with the appointee serving for 3 years, therefore this year there will be no appointment.
